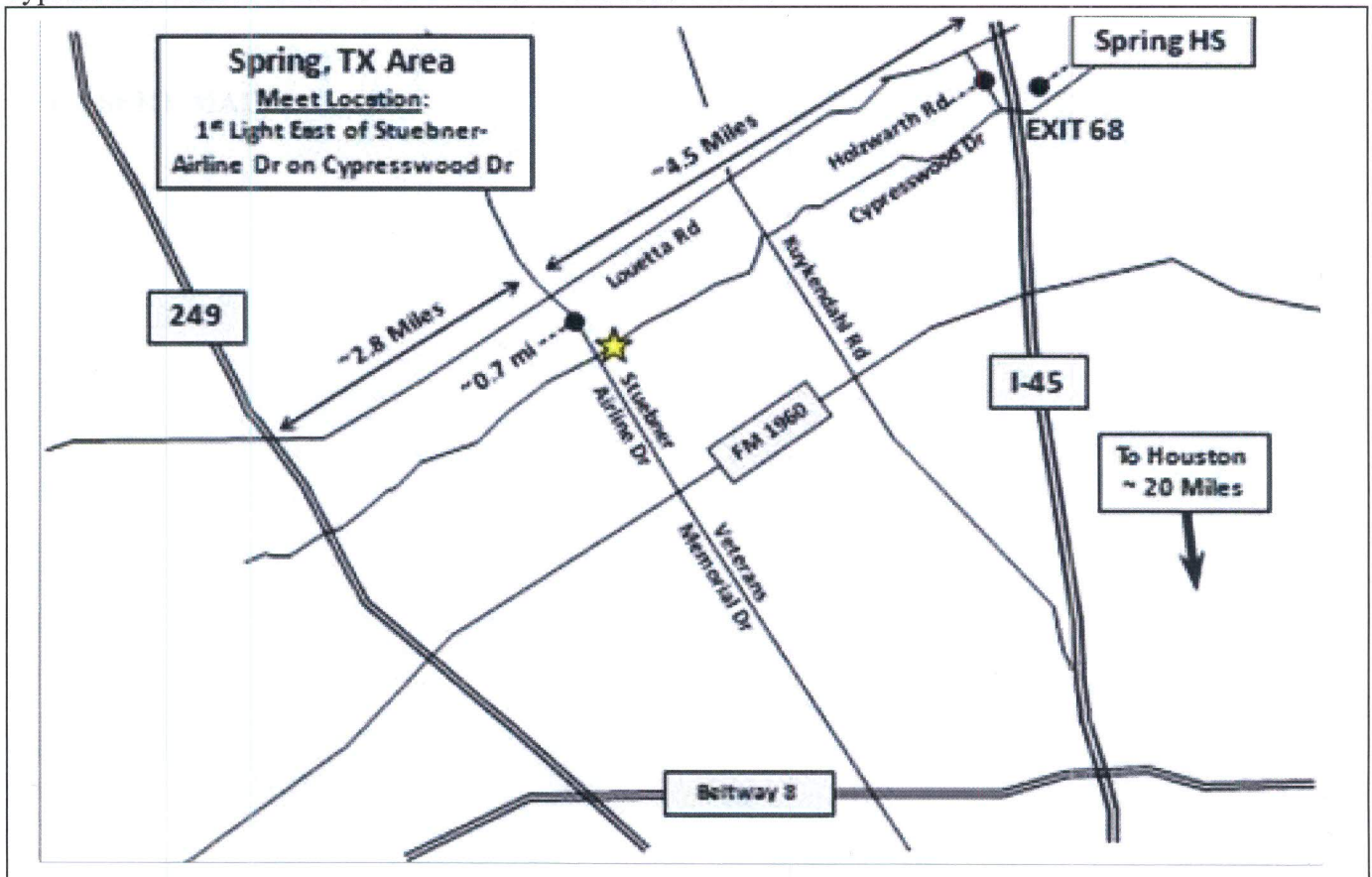

MEET RULES: (1) The meet is open to all TCA members and their guests. Family members and guests are welcome. TCA members will be charged admission. Save money and pre-register!!! (2) Guests and public may buy but not sell. (3) Items on tables must be Covered or Closed Box Rule applies. Socializing will be allowed ONLY in the lobby during setup/pre-registration. If you want to unpack/setup on Friday night, bring something to cover items on your table (e.g., a bed sheet). If you can't cover it, you can't unpack until just prior to trading 9:00 AM. Parts dealers will be segregated and will be allowed to sell parts before trading begins (this means parts only; other items must be covered). No trading or browsing is permitted before 9:00 AM Saturday. (4) Prices must be marked on all items offered for sale. A list is permissible. (5) Restored or reproduction items must be clearly marked. TCA Standards Committee rules are in effect. (6) Badges must be worn at all times in the Trading Hall. (7) All TCA rules and regulations apply to this meet.
